- I acknowledge that my animal(s) is/are up-to-date on all age-appropriate vaccinations, is/are not in heat, is/are not aggressive and, to the best of my knowledge, is/are free from any contagious diseases or condition(s) that would make it a danger to any participant, spectator, other individual, or animal.
- Animals that have been cited by *Victoria BC Animal Bylaw* or applicable statues as dangerous and/or vicious are prohibited from entry into **The Victoria Pet Expo**.
- I acknowledge that I will have control of my animal at all times during the course of the **Victoria Pet Expo** and will adhere to the rules, not only set by the **Victoria Pet Expo** but also the *Victoria, BC Animal Bylaw* regulations. <http://www.vacs.ca/bylaw-regulations>
- I acknowledge and voluntarily accept and assume full responsibility for any risks to me and my animal(s), and further agree I waive and release any and all claims that I may encounter against the **Victoria Pet Expo**, **PV Events Inc.**, it's producer(s), *Corporation of the District of Saanich*, and any and all employees and/or volunteers of the aforementioned organizations and agree not to sue for losses, damages, expenses or fees which arise out of or result from, or are related to in any manner my attendance to the **Victoria Pet Expo**.
- I agree to comply with all rules and regulations pertaining to participation in the event.
